CONTRACT FOR THE UNDERTAKING OF BEING CHRIS WILDRICK

ARTICLE I.

The Agreement and Definition of Terms

This contract between	(henceforth SIGNEE) and Chris Wildrick (a person defined as the originato
of this contract; henceforth WILDRI	CK) establishes that the SIGNEE wishes and is willing to become Chris Wildrick
and that this will be the outcome of t	he signing of this contract, which will take place and effect upon awakening the
next calendar day following the sign	ing. It is understood by both parties that the Becoming of Chris Wildrick by the
SIGNEE is understood to mean that	all the characteristics, traits, and qualities of the SIGNEE, whether physical or
psychological, historical or potential	, ontological or epistemological, metaphysical or moral, will now be known and
redefined as being characteristics, tra	nits, and qualities of Chris Wildrick. Being Chris Wildrick is not a legal identity
and is only a nominative phenomeno	ology.

ARTICLE II.

Benefits, Regulations, and Responsibilities of Being Chris Wildrick

The SIGNEE will be given a photo ID card declaring the SIGNEE's Being as Chris Wildrick, which will be considered active into perpetuity. The SIGNEE may enable others to Become Chris Wildrick. In order to do so, the SIGNEE should email or otherwise contact WILDRICK to get the properly authorized form. The SIGNEE does not need permission from WILDRICK to Redefine others as Being Chris Wildrick, but does need to use the official forms to do so, which are available only from WILDRICK. The SIGNEE understands that Being Chris Wildrick carries no rights or privileges over other card-carrying Chris Wildricks (defined here and henceforth as one or any who have signed copies of this contract, or other versions of it, in the past or future) or WILDRICK, and WILDRICK understands that he is identically hedged in his rights and privileges in regard to the SIGNEE. Neither the SIGNEE nor WILDRICK will undertake any responsibility for malfeasance, heroism, or any other actions or intentions displayed, taken, or not taken by other card-carrying Chris Wildricks. The eventual death of WILDRICK will have no effect on the SIGNEE's Being Chris Wildrick other than that the ability to further Redefine others as Being Chris Wildrick shall be curtailed.

ARTICLE III.

Dispossessing Oneself of Being Chris Wildrick

The SIGNEE may negate this contract at any time simply by wishing to do so. The force of the contract and thus the SIGNEE's identity as Chris Wildrick will be considered void at the awakening of the SIGNEE on the next calendar day after such wish. This wish must be a conscious, lucid thought and not a general preconscious desire. The SIGNEE is required to cut up or otherwise destroy the SIGNEE's ID card within three (3) calendar days of the SIGNEE's first awakening as his/herself or the SIGNEE will automatically revert to Being Chris Wildrick upon awakening on the fourth morning.
